Aligned Primary Care APM Parameters (HB 22-1325) - Ongoing Implementation

Over the course of 2022-2023, the Division engaged the PCPRC and other stakeholders to develop Insurance Regulation 4-2-96, which establishes aligned parameters for primary care APMs in four areas: 1) risk adjustment; 2) patient attribution; 3) core competencies; and 4) quality measures. Moving forward, the Collaborative is tasked with annually reviewing the aligned APMs parameters developed by the Division. The Division is interested in getting member's input/feedback on the best way to structure the review process.
