- 1) The meeting was called to order at 10am by Bobbi Baca
- 2) Jon Pratt volunteered to take minutes
- 3) New Members
 - a) JP Speers introduced himself as a new member
 - b) New member Richard Hart was not in attendance
- 4) There was an election of officers for the new year with the following unanimously decided:
 - a) Marc Rosenberg was elected the new Chairman
 - b) Jacki Paone was elected the new Vice Chairman
- 5) Members whose term is expiring March 31, 2025
 - a) Marc Rosenberg will continue for another term
 - b) Dawn Paluch will continue for another term
 - c) Jon Pratt will complete his term and not continue for another term
 - d) DORA staff with contact Sean Gillette and Dawn Marquantte to ascertain their intent

 - i) J.P. and Peg explained situation and led discussion. Jacki asked if the rapid increase in premiums is much different between a single-family home and a condo/HOA? Bobbie to send the recommendations that Peg made to the entire council for review and further discussion at the next meeting.
- e) Kaiser Network Adjustments with Common Spirit Updates
 - i) Kim provided an update on the new relationship between the two firms. Jacki stated she was afraid there would not be adequate network coverage if Kaiser terminated relationship with Inter-Mountain Health in the future. Kim said DORA was regularly monitoring network adequacy.
 - ii) Marc Rosenberg asked for explanation about the state market place offering PPO's instead of just HMO health plans. Kim Williams explained that is a provider decision.
- 8) Public Comment
 - a) Mark Wynne commented that there should be longer conversation on some important topics. He also asked if there were more than one vendor that bid on the home replacement cost report? DORA staff did not respond to his question.
