**Qualified Jurisdictions:**

Pursuant to Section 10-3-702(6)(d)(I), C.R.S., the Colorado Insurance Commissioner is required to publish a list of qualified jurisdictions under which an assuming insurer licensed and domiciled in such jurisdiction is eligible to be considered for certification by the commissioner as a certified reinsurer.

Pursuant to Section 10-3-702(6)(d)(III), C.R.S., the Commissioner defers to the list of qualified jurisdictions published by the national association of insurance commissioners' committee process.
