Colorado Option Messaging Focus Groups

Last fall, the Division contracted with a strategic communications firm to analyze the messaging used for the Colorado Option and to understand consumers' views on the Colorado Option plans. Participants were shown a short video and a one-page flyer about the Colorado Option and were invited to discuss their thoughts on the materials and general thoughts about purchasing health insurance.

Focus Group Logistics and Participant Makeup

- Two 90 minute focus groups held, one on February 3rd and one on February 4th
- Both focus groups were held online via Zoom and participants were paid \$100 for their participation
- Participants recruited from throughout Colorado through the CREA Results network and with assistance from Connect for Health Colorado
 - One focus group had primarily urban, front range participants, and the other had participants from other parts of the state
 - Focus groups included 10 White/Caucasian participants, 10 Black/African American participants, 6 Hispanic/Latino participants, 2 Asian/Pacific Islander participants, and 1 Native American/Alaska Native participant.

Feedback on Messaging & Outreach

Generally, there was positive feedback on messaging around affordability and inclusivity both in the video and the one pager. Participants expressed interest in free primary care and mental health care but remained focused on specialty care and were somewhat skeptical of the accessibility (useability) of the plan. Despite these concerns, participants were generally open to the plan as advertised and showed positive interest in the affordability, free benefits, clear pricing, and inclusivity of Colorado Option plans.

Next Steps

The DOI will continue to analyze the feedback from the focus groups to inform its messaging for Colorado Option plans prior to the Plan Year 2026 Open Enrollment Period.
