For: Listed Property & Casualty Insurers writing Homeowners Multi-Peril Policies in Colorado

Re: Wildfire & Hail Policies, Discounts and Premiums Data Call

The Division is issuing a survey on wildfire and hail discounts. This survey is due by August 12, 2025. The survey, once completed, may be returned by email to Mitchell Bronson at [Mitchell.Bronson@state.co.us](mailto:Mitchell.Bronson@state.co.us). Questions regarding the survey can also be directed to the same email address. The applicable companies to which this survey applies are contained in the list entitled "Wildfire & Hail Policies, Discounts and Premiums Data Call Applicable Insurers".

Companies will refer to the survey instructions provided in the excel reporting template's "Instructions and Definitions" tab. Insurers must provide a response to the Division for the survey even if the company does not have any experience to report. Please note the survey should contain aggregate claims data for premiums, losses and policies as of July 15, 2025. If you have difficulty accessing the survey, please press F5 to refresh your browser manually to ensure it is not viewing an old version of the web page.

The Division of Insurance is collecting information from the top 20 property and casualty carriers writing homeowners multi-peril policies in Colorado. The survey will apply to the following lines of business: Homeowners Multiple Peril.

Please note that Colorado Insurance Regulation 1-1-8 requires that every person shall provide a complete response in writing to any inquiry from the Division of Insurance. This reply must be postmarked, if mailed, or received by 5:00 p.m. Mountain time by the Division if sent electronically or by any other means, by August 12, 2025. If this due date falls on a weekend or national holiday, the due date is automatically extended to the first business day immediately following the specified due date. If additional time is required to provide a complete response, including any documentation which is requested, a request for an extension of time must be made, in writing, prior to August 12, 2025.

The request for an extension of time must state the reason for such request and the number of additional days required to provide a complete response. Requests for additional time will be granted for good cause shown and for a reasonable period at the discretion of the Division. Requests for an extension of time may be transmitted by facsimile or email.

Failure to provide a full or complete response, or to request an extension for a specified period, may result in the imposition of at least a \$500 fine under Colorado Insurance Regulation 1-1-8 and an applicable surcharge pursuant to §24-34-108(2), C.R.S. This surcharge will be used to fund the development, implementation and maintenance of a consumer outreach and education program. Pursuant to Section 6 of Colorado Insurance Regulation 1-1-8, and after notice and hearing, additional sanctions may be sought under C.R.S. 10-1-215 and other fining and penalty provisions of Title 10.
